Instructions

The correct title application fee (\$15.00) must be submitted in certified funds that are payable to the Alabama Department of Revenue. No personal checks. Please verify that there is a current Alabama certificate of title in the name of the owner(s) listed on the face of this application, prior to submitting this application. Title application fees are not refundable or transferable.

Section 1 Enter the vehicle identification number that appears on the vehicle in the appropriate block. Enter the make and year model in the appropriate blocks. Enter the Alabama License Plate number that is currently on the vehicle in the appropriate block.

Enter the owner(s) name(s) exactly as it appeared on the original Alabama Certificate of title being replaced. Enter the owner(s) current address in the appropriate block. If it is necessary to verify owner information, call Title Inquiry at (334) 242-9102. Note: the complete vehicle identification number will be necessary to obtain any vehicle information.

- Section 2 Enter the name and address where the replacement title is to be mailed. Note: if the replacement title is to be mailed to someone other than the owner or lienholder, the owner or his/her authorized representative must complete Section 7 in its entirety.
- Section 3 Check the appropriate block to disclose the reason a replacement title is required. Note: a replacement title cannot be used to avoid obtaining title in the name of someone who had possession of the vehicle (skipping title) and was required to obtain title in their name. Using this form to skip title can be a criminal act under the Uniform Certificate of Title and Antitheft Act and can result in the revocation of a certificate of title.
- Section 4 Check the appropriate block to disclose whether the owner or lienholder is applying for the replacement title.

 Note: the terms owner and lienholder refer to the owner and lienholder that were listed on the Alabama certificate of title being replaced.
- Section 5 The lienholder requesting the replacement title must complete Section 5 in its entirety. If the lienholder has released their lien on the vehicle, Section 6 must also be completed in its entirety. Note: do not complete Section 6 if the lien has not been released or if vehicle has been repossessed by the recorded lienholder. Recorded liens, if not released, will be reflected on replacement certificate of title.
- Section 6 The lienholder(s) on the Alabama certificate of title can release their lien(s) by completing Section 6.
- Section 7 The owner(s) of the vehicle or owner's authorized representative must complete this Section unless the replacement title is being sent to the recorded lienholder. If someone other than the owner completes Section 7, a notarized power of attorney must accompany the application.
